

## Office Order

In exercise of the powers conferred under the Bihar Air (Prevention & Control of Pollution) Rules, 1983 the fee for application for consent to establish (NOC) under the Water (Prevention & Pollution Control) Act, 1974 and the Air (Prevention & Pollution Control) Act, 1981 and that for consent to operate under the Air (Prevention & Pollution Control) Act, 1981 is prescribed as below :
